Dear Mr. Speirs,

I refer to your application received on 13 September 2023 requesting information under the *Freedom of Information Act (SA) 1991* (the FOI Act).

### Application

I note the scope and content of your request:

*“A copy of all documents, including but not limited to email, diary notes, text messages, whatsapp messages, relating to the referral of FOI no 18056459 to the Premier’s Delivery Unit. Date range 17/07/2023 to 13/09/2023 (inclusive).”*

### Documents Sourced

A comprehensive search for documents relating to the referral of FOI no 18056459 (AA23/1285) to the Premier’s Delivery Unit were undertaken in order to identify and locate documents within the scope of your application. A summary of documents that were identified are listed in the attached schedule.

### Determination

I have made a determination to release a copy of the documents you have requested with the exception of information deemed to be exempt under section 20 (1) (a) of the Act. My determination is set out below.

Documents 1 to 3 (as outlined in the attached schedule) have been partially exempted in accordance with clause 6 (1) of Schedule 1 to the FOI Act on the grounds that it contains the personal affairs of a third party. The information is considered to be confidential, and the document has been redacted to this extent.

Clause 6 (1) states:

*A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).*

### **Fees and Charges**

As the processing of your application did not exceed the threshold for members of parliament pursuant to regulation 6 of section 53(2) of the Act, no additional fees or charges have been applied on this occasion.
