# Mental Health services in the Return to Work Scheme

# ReturnToWorkSA introduces NEW mental health fee schedules

Medical and allied health services are critical to the success of the Return to Work Scheme (the Scheme) by ensuring workers have access to appropriate treatment services to support their recovery and/or return to work. In the Return to Work Scheme (the Scheme), Psychologists provide treatment for the vast majority of workers with a psychological injury despite several allied health provider groups having specialist mental health training. We support workers having access to a wide variety of services according to their individual circumstances. For that reason, we have created a mental health category of fees, inclusive of a new Mental Health Occupational Therapy fee schedule and policy.

#### Who is ReturnToWorkSA?

ReturnToWorkSA provides South Australian employers with insurance to protect their business and their workers in the event of a work-related injury. We support people who have been injured by providing financial support which covers wages, access to reasonable medical treatment and a range of return to work services to help them recover and return to work. We also administer the Scheme by collecting insurance premiums from employers and ensuring all Scheme participants are aware of their obligations under The Return to Work Act 2014 (the Act).

#### Why create a Mental Health Occupational Therapy Fee Schedule?

ReturnToWorkSA want to raise awareness of the range of mental health services supported by the Scheme. Sometimes there can be confusion around what can and cannot be paid for or the misconception that without a fee schedule, a particular service cannot be accessed. A fee schedule provides clear instruction on what type of services can be paid for as well as the amount prescribed.

#### Who can provide services under the Mental Health Occupational Therapy Fee Schedule?

Occupational Therapists registered with the Australian Health Practitioners Regulation Authority (AHPRA) who have:

- 1. Mental Health Endorsement by Occupational Therapy Australia; AND
- 2. Completed ReturnToWorkSA's online module for mental health practitioners, <u>ReturnToWorkPsych.</u>

#### How do I register to provide services?

## Please complete and submit the <u>service provider registration form</u> to <u>ReturnToWorkSA</u>, providing a copy of:

- 1. Membership with the applicable professional association and/or evidence of endorsement; <u>AND</u>
- 2. <u>ReturnToWorkPsych</u> certificate of completion

## What if I am already registered to provide services with ReturnToWorkSA?

Please help us verify your eligibility to provide services by <u>emailing us</u> a copy of your:

- 1. Mental health endorsement
- 2. Professional association membership
- 3. <u>*ReturnToWorkPsych*</u> certificate of completion

# To assist, please <u>send this to us</u> with your documents:

#### Which fee schedule will I work under if I am eligible to provide services in more than one?

While we recognize that many practitioners will have a broad skill set, and may be able to work within more than one fee schedule. Whilst there may be an overlap of the fee schedules the expectation would be that you invoice under the fee schedule for the service that you have been referred to. i.e the mental health occupational therapy fee schedule if you have been asked to deliver mental health services.

#### How will I get referrals?

We would encourage you to reach out to local medical practices and other allied health providers to let them know of your availability and willingness to work in the Scheme.
